Knight Marshall

An Overview:

This last month there have been a number of marshallate activities available for people to attend. Demos, events, practices.

There were reasonable showings of our HW combatants at a number of activities.

• Armor inspections:

Though we do inspections each time we fight, with Pennsic coming up please remember that the marshals will be keeping a strict eye on your gear. If YOU think it might be unsafe, FIX IT before you bring it to the marshals. If you aren't sure, bring it to us, and we'll help you figure out how to make it work, or how to replace it.

Both Pykh and Septimus have been asked (or will be asked) to a thorough inspection of each person entering the HW list field. If your gear doesn't meat standards, you need to work on it, ASAP.

When in doubt look at the Kingdom site for the links to the rules of the list, armor inspection, etc.

Armor repair:

The loaner gear is in serious need of repair.

Almost every item in the loaner box either needs a major over haul to meet current armor standards, or needs to be replaced. Myself and my deputies are working on getting a repair inventory request together to submit to the financial committee.

If you would like to assist in repairing the loaner armor, please contact myself, Pykh or Septimus to arrange to help out. (If you can swing a hammer, turn a screw, or hold things down you too can be part of the armor repair group)

Deputies defined:

Septimus is my "JAW" deputy - meaning just add water. He is poised to take over the marshallte should the need arise. Christian Pykh - Pykh is a senior HW deputy . I have made him the loaner armor deputy. so everything in the loaner gear will be checked out through him.

As a friendly reminder to the populace: You MUST sign a waiver, at any and all SCA events, which includes practices, if you cannot show CURRENT Proof of a Waiver on File. This Proof includes: an SCA Blue Membership Card that is Current, and/or a Current Yellow Authorization Card. Even if the MIC KNOWS you are current, You Still Need to Show EITHER Card, as per Kingdom AND Society Policies.

A Waiver is NOT a sign in sheet, so it should not be used as one, as per Kingdom AND Society Policies. A MIC, for that specific discipline, can use a Combat sign in sheet, if they want to have a record for the Combatants who choose to participate. A MIC can ask noncombatants to sign the combat attendance sheet; HOWEVER, you cannot require said people to do so.
